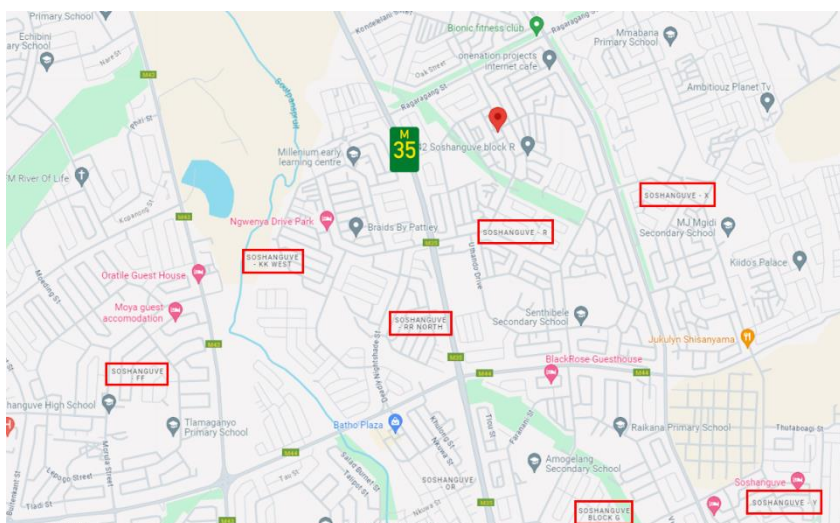
This property is situated in Soshanguve township situated about 30 km north of Pretoria.

This modern plastered home has a tiled roof and spacious rooms. This secure property is walled on all sides with a palisade and brick wall facing the street.

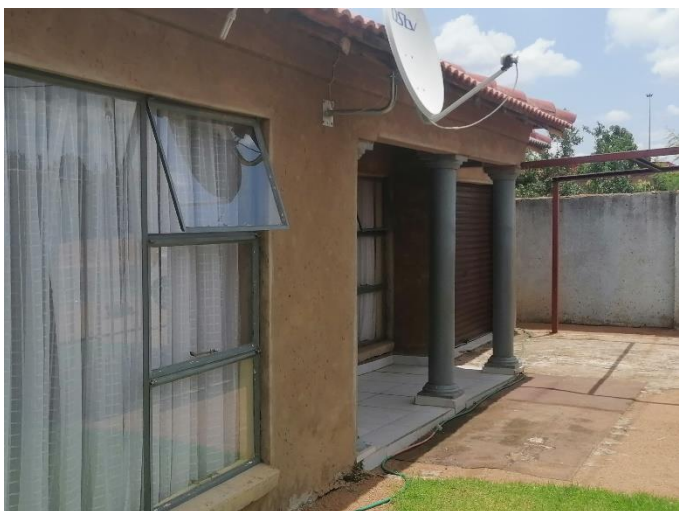
